

Healthcare Applications Policy

Nexeo Plastics, LLC and its subsidiaries and affiliates (Nexeo Plastics) distribute plastics products (Materials). This policy applies to the sale of Materials for use in “healthcare applications.” We define *Healthcare Applications* as: “Incorporation of any Material in products intended for use in the diagnosis, cure, mitigation, treatment or prevention of disease or intended to affect the structure, appearance or any function of the human body.” In general, the term Healthcare Applications includes, but is not limited to, drugs (including both prescription and over-the-counter drugs) and products regulated as Class I, II or III medical devices (including packaging) by the US Food and Drug Administration, including injectable materials used in cosmetic or other medical procedures.

Nexeo Plastics does not sell or provide samples of Materials or technical support for certain drugs or Class I, Class II and Class III medical devices, including injectable applications. Therefore, all potential or known Healthcare Applications must be reviewed by Nexeo Plastics’ personnel pursuant to Nexeo Plastics’ Healthcare Applications Pre-Screening Procedure.

POLICY

Prior to placing an order with Nexeo Plastics, each customer considering using any Materials supplied or distributed by Nexeo Plastics in what is known to be or is *potentially* a Healthcare Application as defined above must: (1) notify Nexeo Plastics’ personnel; (2) acknowledge receipt and understanding of Nexeo Plastics’ Healthcare Applications Policy, and (3) complete Nexeo Plastics’ Healthcare Applications Pre-Screening Form or Nexeo Plastics’ Healthcare Applications Policy Acknowledgement Form, as applicable, in addition to any documents required by Nexeo Plastics’ suppliers. Nexeo Plastics retains the right to decline to supply any Material for any reason.
